A public meeting of the Port Commission of the Port of Houston Authority of Harris County, Texas was convened on July 31, 2018 at 9:00 a.m., at the Port of Houston Authority Executive Offices, Fourth Floor Boardroom, at 111 East Loop North, Houston, Texas 77029. The following Commissioners, staff and counsel were present:

J. Kent Friedman, outside counsel, arrived at 9:17 a.m.

Chairman Longoria convened the meeting of the Port Commission, welcomed everyone, and provided remarks as follows.

- Chairman Longoria asked the interns to stand up and noted that Mr. Guenther would be recognizing them in his comments.
- The M/V Sam Houston, originally called the "Show Window to the Port," was christened on July 30, 1958 by Karen Tellepsen, and is celebrating its 60th anniversary. Since then, the public tour has showcased the Port of Houston to nearly 2 million visitors, and offers visitors a unique opportunity to get an upclose look at one of the busiest ports in the nation. The M/V Sam Houston hosts 10 free tours a week, carrying up to 100 passengers per sailing. Chairman Longoria encouraged everyone in attendance to take the tour if they had not already done so.
- Chairman Longoria recognized the Small Business and Maritime Education
 Department, noting that the Port Houston Partners in Maritime Education
 program was selected for Honorable Mention in the 2018 National Career
 Pathways Awards program. The awards are sponsored by the National Career
 Pathways Network, which strives to share information on exemplary practices,
 collaborate to develop implementation resources, and foster communication
 about career pathways and other workforce education programs.

The Career Pathways Award emphasizes the importance of career guidance for students, professional development for educators and employers, and the employer's role in providing work-based learning opportunities for students, similar to the interns present today. It is a great honor to receive this type of

recognition on a national level and Chairman Longoria congratulated Gilda Ramirez, Senior Director, Small Business and Education Outreach, and her staff on the achievement.

• Chairman Longoria announced that the next Port Commission meeting would be held on September 25, 2018.

(2018-0731-01) Minutes

Chairman Longoria called for a motion to approve the minutes of the June 26, 2018 Port Commission meeting. Commissioner Kennedy moved for approval, seconded by Commissioner Fitzgerald.

Commissioner Corgey commented that the minutes did not reflect the discussion of agenda Item L1. Mr. Eriksson responded that the discussion was summarized but that more detail could be included. Chairman Longoria asked which matter his comment related to and Commissioner Corgey indicated it was the item regarding vessel spotting. Chairman Longoria asked Mr. Eriksson to take a look at the matter; he agreed to do so.

Chairman Longoria called the vote to approve the minutes with the requested change. Chairman Longoria, and Commissioners Corgey, DonCarlos, Fitzgerald, and Kennedy voted Aye. Nays none. The minutes were approved as amended.

(2018-0731-02) Chairman Longoria reported on the Audit Committee Meeting – July 26, 2018.

Chairman Longoria reported that the Committee reviewed Grant Thornton LLP's contract for professional auditing services and recommended that the option to extend the professional services agreement for an additional one-year term be exercised, requested approval by the Port Commission, and asked that the item be taken out of order and voted upon.

(2018-0731-03) RCA I3 was presented, moved by Commissioner Corgey, seconded by Commissioner DonCarlos. Chairman Longoria, and Commissioners Corgey, DonCarlos, Fitzgerald, and Kennedy voted Aye. Nays none. RCA I3 PASSED.

She went on to report that staff had performed a self-assessment of the Port Authority's compliance with the Audit Committee Charter, Internal Audit Charter, Texas Special District Local Laws Code Chapter 5007, and Texas Government Code Chapter 2102, and indicted that the Port Authority is in compliance with the regulations. Chairman Longoria thanked Mr. Eriksson and Ms. Buckles for their excellent work in ensuring that the Port Authority remains in compliance with these regulations.

The Committee also completed its annual review of the Audit Committee and Internal Audit Charters, and Internal Audit Policies. Staff affirmed that these documents continue to be consistent with Institute of Internal Auditors Standards. There were no proposed changes to the documents. The Committee concurred with staff's review and recommended reconfirmation of the Audit Committee Charter, Internal Audit Charter, and Internal Audit Policies as presented in agenda Item G1.

Staff conducted its annual review of Grant Thornton LLP and Lead Partner qualifications. Both continue to be in good standing with the Texas State Board of Public Accountancy. Ms. Dunlap has served as the engagement partner on the last eight audits and is considered highly qualified and competent to continue in this capacity and recommended same to the Committee, the Committee concurred.

Staff also provided audit reports to the Committee related to the following

- 1. Review of third-party hosted sites and related assessment of service organization controls;
- 2. Wharf 46 construction audit;
- 3. Wind power revenue audit; and
- 4. The Promotion and Development Fund fourth quarter 2017 and first quarter 2018 reviews.

Staff informed the Committee that there was one issue reported under the Port Authority's "whistleblower" policy during the period March through June 2018. The matter was considered a Human Resources issue regarding communication and has been resolved.

Chairman Longoria asked if there were any questions. There were none.

(2018-0731-04) Appearances

(a) Chairman Longoria introduced Al Maldonado, District Director, League of United Latin American Citizens (LULAC), who addressed the Port Commission.

Mr. Maldonado requested that the Port Commission conduct a diversity study to ensure its contracting practices and award system is fair and equitable to the Hispanic and minority communities. He stated that Port Houston's current procurement system encourages Minority Women Business Enterprises ("MWBEs") through the Small Business Development Program, but the system is based on only the race-neutral means. He also requested that a meeting be held with his group and commissioners to discuss the employment representation of Hispanics and minorities in all levels.

Chairman Longoria thanked Mr. Maldonado for his comments.

(b) Chairman Longoria introduced Ingrid Robinson, President, Houston Minority Supplier Development Council, who addressed the Port Commission.

Ms. Robinson gave a brief overview of the Council and emphasized the economic impact that the Council has in Houston and the surrounding area. She also requested that the Port Commission conduct a diversity study regarding minority-owned small businesses, in order to identify the ethnic breakdown and gender breakdown on small businesses that are currently enrolled in Port Houston's Small Business Development Program.

Chairman Longoria thanked Ms. Robinson for her comments.

(c) Chairman Longoria introduced Yolanda Smith, Executive Director, National Association for the Advancement of Colored People (NAACP) – Houston Branch, who addressed the Port Commission.

Ms. Smith concurred with the two previous speakers and stated that much more needs to be done to level the playing field. She requested that Port Houston quantify the actual impact of the Small Business Development Program by collecting and publishing the percentages of MWBEs that are vendors, and also requested that Port Houston conduct a disparity study to investigate its current practices and policies and help promote equality for the communities.

Chairman Longoria thanked Ms. Smith for her comments.

(d) Chairman Longoria asked if anyone else would like to address the Port Commission; there was no response.

Chairman Longoria congratulated Roger Guenther on behalf of the Port Commission and staff for being named as one of the "Most Admired CEOs" by the *Houston Business Journal*, noting that Port Authority employees had nominated him to receive the recognition. Mr. Guenther expressed his appreciation for being able to serve in the position and for the Port Commission and staff that he works with.

(2018-0731-05) Staff Reports

Mr. Guenther presented a summary of operational and financial matters as follows:

- Mr. Guenther announced that through the second quarter of 2018, Port Houston had moved 1.3 million twenty-foot equivalent units ("TEUs"), for a 6% increase over 2017. In addition, steel trade had increased 21% over 2017, with imports of 2.1 million tons to date.
- The Bayport Container Terminal had the largest number of box lifts for a vessel in its history in July, when more than 4,800 lifts were completed on a 6,400 TEU class vessel from East Asia. This was made possible with the expansion of the Panama Canal, and the investments Port Houston has made in deepening and widening the channel and other capital improvements, in order to accommodate these larger vessels. This move was accomplished at a very productive rate with the partnership of Port Houston operations personnel in addition to stevedores and laborers.
- The first half of 2018 has produced operating revenues of \$179 million. Each sector of the business has experienced revenue growth in the first six months, led by the volume increases of the container business.
- Mr. Guenther noted that on the agenda for commission consideration were requests for more than \$70 million in capital project awards and advertisements, to keep commerce moving through Port Houston and maintain capacity for the high demand in the future.
- It was estimated that the three new cranes for the Bayport Container Terminal will arrive August 6.
- Mr. Guenther concluded his report by recognizing the students who are participating in the 2018 internship program. Mr. Guenther reported that the interns have been working very hard on individual projects, were reaching the completion of the program, and would conclude with a group presentation to senior leadership in August. He asked the students in attendance to introduce themselves, state the departments they interned for, and the universities they were attending.

Background:

Ben Line Agencies Singapore, Limited, an independent contractor, using its experience for over 150 years in the shipping industry in Asia, its established network of over 100 offices across 15 countries, and its proven abilities, has continued to promote Port Authority facilities and services while helping maintain a positive image of Houston across Asia.

By Minute No. 2016-0726-05, the Port Commission authorized the award of a contract to Ben Line Agencies Singapore, Limited, for a two-year term in an amount not to exceed \$370,000.

In 2017, East Asian imports through the Port Authority container facilities grew over 25%. Trade with Asia now represents 29% of the total volume of import and export containers which move through Port Authority Terminals. China was the Port Authority's number one country for container trade in 2017 and accounted for 22% of all loaded containers, more than three times that of the next highest country of Brazil.

With the addition of the Maersk/MSC 2M service (that launched in May 2016), increasing Asia service vessel sizes, and high beneficial cargo owner demand for cargo routing through the Port Authority, Asian volumes are expected to continue to trend upward, and Asia continues to represent the fastest-growing trade area for the Port Authority.

Staff Evaluation/Justification:

Based on these circumstances, staff recommends the Port Authority advance its strategic positioning in Asia (i.e., China, South Korea, Japan, Hong Kong, Taiwan, Singapore, Philippines, Thailand, Indonesia, Malaysia, Vietnam, Cambodia, Myanmar, Australia, Sri Lanka, and India) through the award of a new two-year and three month contract with Ben Line Agencies Singapore, Limited, not to exceed \$425,024.91 during the entire term of this Agreement (\$11,158.33 per month), including Port Authority related travel and business expense reimbursement not to exceed \$55,000 per year including \$13,750 for the three months ending December 31, 2020. The Port of Açu is an upcoming multi-purpose port located in central Brazil and is considered by Port Authority staff as a key partner to help grow Port Authority trade in that country. In addition, the Port of Açu has a strategic partnership with the Port of Antwerp on the Europe – South America trade, as the Port Authority does on the Europe – U.S. transatlantic trade.

The Port of Açu has now approached the Port Authority to request a Memo of Friendship and Trade Cooperation, based on the potential synergies and interests that we share. This instrument would record the parties' intention to work together to develop and expand mutual understanding and cooperation in an effort to promote greater economic benefits for both ports.

The Memorandum of Friendship and Trade Cooperation would provide that the parties may elect to undertake joint marketing activities and share information regarding trade, marketing, modernization and improvements, training programs, and technology. The Port Authority is seeking to renew International Business Machines Corporation's (IBM's) Cognos budgeting and reporting software, which is currently being used as a tool for budget preparation, financial reporting, and cargo statistical reporting, and purchase annual subscription and support services to provide for software revision upgrades and technical support.

The Texas Department of Information Resources (DIR) is a department of the State of Texas. DIR has a cooperative purchase contract DIR-TSO-3996 (DIR Contract) with Mark III Systems, Inc.

The DIR Contract with Mark III Systems, Inc. authorizes IBM to designate a third-party to fulfill customers' purchase orders pursuant to conditions set out in the DIR Contract; such third-party is defined in the DIR Contract as an Order Fulfiller.

Staff Evaluation/Justification

The Director of Procurement Services has determined that procuring IBM's Cognos budgeting and reporting software through the Texas Department of Information Resources' (DIR) purchasing program is the method that both satisfies competitive purchase requirements and provides best value to the Port Authority.

IBM has notified the Port Authority that IBM has designated Mark III Systems, Inc. as one of IBM's Order Fulfillers and qualified resellers under the DIR Contract, and has requested that the Port Authority accept Mark III Systems, Inc. as IBM's Order Fulfiller for the Port Authority's purchase of services and implementation under the DIR Contract.

Due to the uncertain nature of emergency management, it is in the best interests of the Port Authority to have a "stand-by" hazardous materials incident response services contract in place for the safety of personnel and the environment. By having competitively procured the contract, in advance of an incident, the Port Authority is eligible for potential reimbursement from the Federal Emergency Management Agency (FEMA) in a declared disaster.

Staff Evaluation/Justification:

This \$150,000 amendment to the contract amount is requested to cover the current invoice and provide a balance on the purchase order for potential future events. Accordingly, staff recommends that the Port Commission approve the proposed \$150,000 amendment to the existing contract with Oil Mop LLC dba OMI Environmental Solutions.

Background:

Approximately 2,500 ships called Port Houston facilities in 2017. Historically, Port Police have met each ship upon arrival and coordinated with the Houston Pilots and the mooring companies' line handlers to spot the vessel's location on the wharf. Upon conclusion of that process, Port Police then input arrival and departure data in the Port Authority's Navis Operating System to initiate billing associated with the vessel visit.

Currently, two mooring companies operate at Port Authority facilities, and one or the other is appointed by the vessel's owner or the owner's representative to provide vessel services. In an effort to streamline the efficiency of arrival and departure of ships, staff has entered into short term contracts with both providers and seeks to enter into long-term contracts to provide spotting services. Port Police no longer have these responsibilities.

Background:

By Minute Nos. 98-0824-15, 2003-0127-43 (Amendment No. 1), 2008-0722-41 (Amendment No. 2), and 2008-0826-35, the Port Commission awarded a contract to ITS Technologies & Logistics, LLC f/k/a In-Terminal Services Corporation (ITS) for the operation of the Port Authority's Intermodal Rail Ramp at Barbours Cut Terminal. The original contract commenced on August 24, 1998 and was again awarded to ITS on August 24, 2008 for a ten-year term. The Port Authority does not compensate ITS for its work under the contract; rather ITS is paid on a per-lift basis by the railroads served at the Rail Ramp. ITS reimburses the Port Authority monthly for utility costs on a per-lift basis.

ITS's work under the agreement includes loading and unloading containers to and from railcars, coordination with Port Authority Operations and the trucking industry for pick-up and delivery of containers, shifting of railcars as necessary, and preparing outbound trains in accordance with railroad policies. The railroads have indicated that they are satisfied with ITS's operation of the Rail Ramp.

In order to provide the Port Authority with adequate time to evaluate future operation of the Rail Ramp, the Port Authority and ITS have agreed to a one-year extension of the current agreement.

Microsoft ended mainstream technical support for SharePoint 2010 in 2015 and extended support will end in 2020. Likewise, the Gimmal add-on which allows us to meet regulatory and compliance requirements for documents and records is also out of support. The Port Authority will be migrating to SharePoint 2016 and upgrading the Gimmal records management software to ensure ongoing technical support of this critical platform.

Port Authority staff seeks assistance with implementation and migration services in support of this migration. These services will augment hands-on work done by our internal technical team.

Staff Evaluation/Justification:

The Director of Procurement Services has determined that procuring information technology implementation services through the United States General Services Administration (GSA), an agency of the United States, is the method that both satisfies competitive purchase requirements and provides best value to the Port Authority. The Port Authority, as a political subdivision of the State of Texas, is authorized to use GSA for the procurement of certain items (primarily technology, security, and fire/police items).



The Information Technology department has determined that the best availability, price, and contract term for the services needed is provided by ECS Federal, LLC under the pricing schedule obtained from that vendor's contract with United States General Services Administration (contract GS-35-0601K) and is therefore recommending this purchase.

Accordingly, staff recommends that the Port Commission approve this best value determination and contract.
