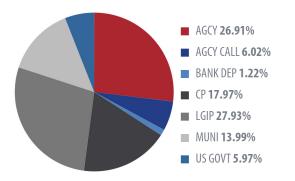

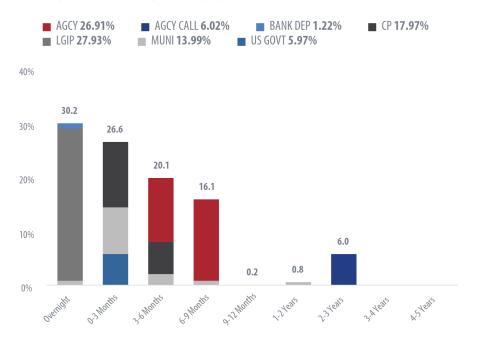

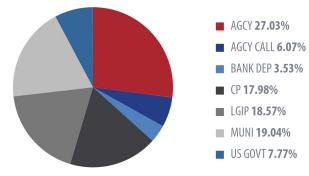

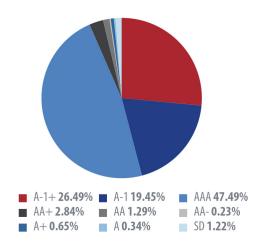

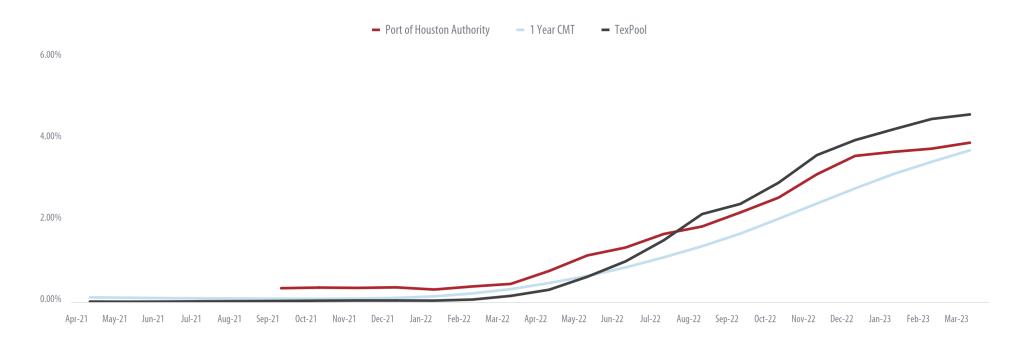

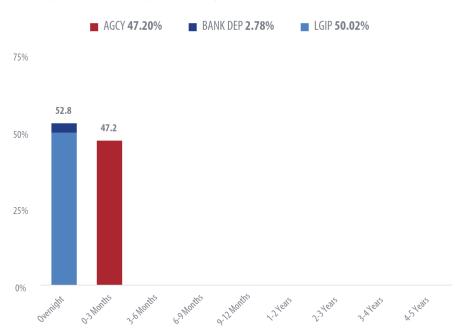

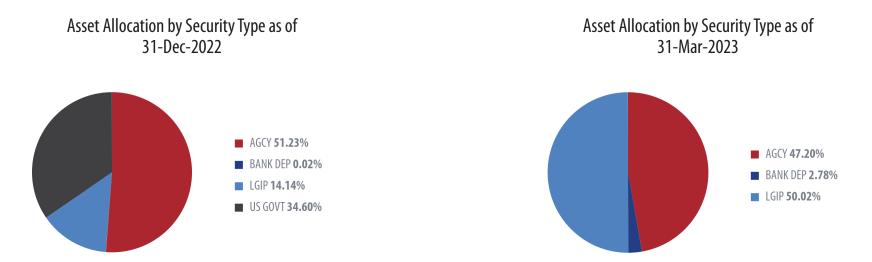

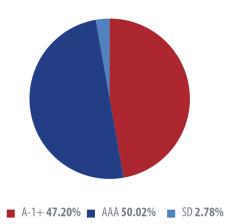

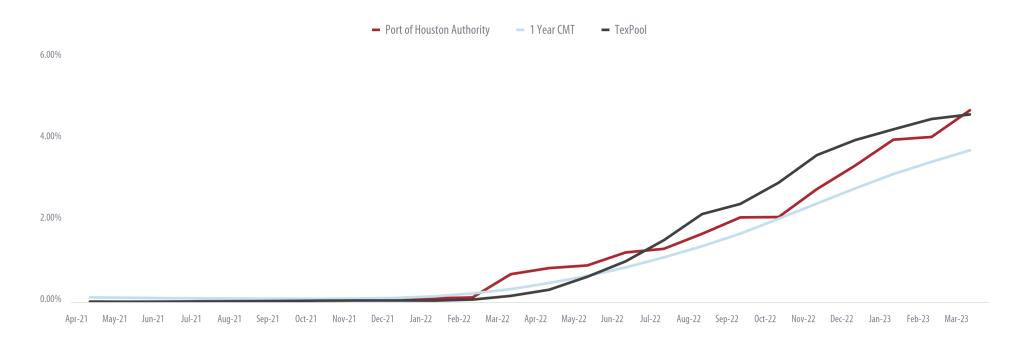

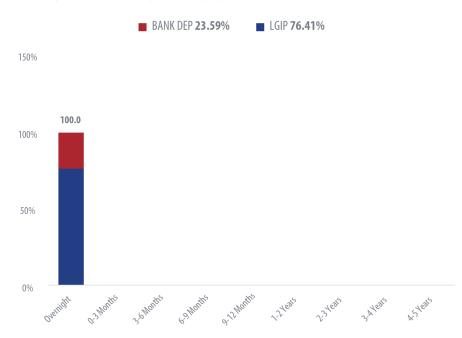

Allocation by Rating

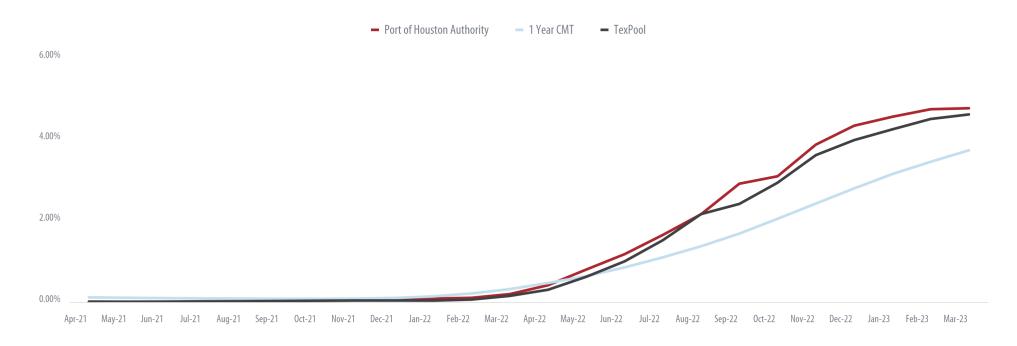
