Background:

Pursuant to the Texas Tax Code §11.13, taxing units, including the Port Authority, must adopt the amount of their tax exemptions for the 2023 tax year before July 1, 2023. Tax Code §§11.13(d)(1) and (e) also authorizes the Port Commission to exempt from property taxation no less than \$3,000 of the appraised value of the residence homestead of an individual who is disabled or is 65 years old or older.

For eligible taxpayers, the Port Authority currently provides a homestead exemption equal to 20% of the value of a home plus a \$250,000 exemption for eligible homeowners who are age 65 or over, or disabled.

Staff is informed by the Harris County Tax Collector's office of Budget Management that Harris County Commissioner's Court has increased the 65 or over, and disabled homestead exemption amount, from \$250,000 to \$275,000, to help offset the increase of home values.

Staff Evaluation/Justification:

Port Authority staff recommends that the Port Commission adopt an order in the form attached as Exhibit "A," whereby it will exercise its authority to exempt from property taxes portions of the appraised value of certain residence homesteads for the Tax Year 2023 and thereafter, as follows:

\$5,000 or 20% of the appraised value, whichever is greater, of an adult's residence homestead; and \$275,000 of the appraised value of residence homestead of an individual who is disabled; or \$275,000 of the appraised value of residence homestead of an individual who is 65 years old or older.

As in the past, these exemptions will be in accord with Harris County practice.

Texas Tax Code §11.13(d)(1) and (e) authorizes the Port Commission of the Port of Houston Authority of Harris County, Texas, to exempt from property taxation \$3,000 of the appraised value of the residence homestead of an individual who is disabled or is 65 years old or older, unless a larger amount is specified by the Port Commission.

The Port Commission desires to approve certain larger appraised value amounts of exemptions to be granted for certain residence homesteads.

ORDER

Pursuant to Texas Tax Code §11.13(d)(1) and (e), as amended, the Port Commission of the Port of Houston Authority of Harris County, Texas exempts from ad valorem taxation for tax year 2023 and all future years, unless revised, the following amounts of the appraised value of a residence homestead:

- a. \$5,000 or 20% of the appraised value, whichever is greater, of an adult's residence homestead; and
- b. \$275,000 of the appraised value of the residence homestead of an individual who is disabled; or
- c. \$275,000 of the appraised value of the residence homestead of an individual who is 65 years old or older.

Background:

As currently enacted, Texas Water Code Sec. 60.403(a) provides that a port commission, an authorized designated officer of the port commission, the executive director of the port authority, or an authorized representative of the executive director may make routine purchases or contracts in an amount not to exceed \$50,000.

Section 1 of Senate Bill 1500, of the Regular Session of the 88th Legislature, amends Water Code Sec. 60.403(a) effective June 18, 2023, to permit a port commission to delegate additional authority for routine purchases or contracts in an amount not to exceed \$100,000.

Various provisions in Chapter 60 of the Water Code would follow Sec. 60.403(a) in adopting the \$100,000 threshold for certain port authority actions, if its port commission has delegated that authority: \$100,000 would become the threshold amount requiring (i) a formal procedure for emergency purchases (Sec. 60.4035(a)); (ii) formal procurement methods (Secs. 60.404, 60.405, and 60.406); (iii) awards by a port commission at public meetings (Sec. 60.408); and (iv) change order approval by a port commission (Sec. 60.410).

Note separately that the same bill expands the instances when emergency purchases exceeding the threshold amount are permitted, to better address supply chain challenges and similar circumstances.

According to the Legislative Bill Analysis, Senate Bill 1500 seeks to enact administrative changes that will allow Texas port authorities to be more efficient and cost effective, consistent with inflation and changes in supply chain logistics, thus enhancing the state's economic development.

Staff Evaluation/Justification:

Port Authority staff recommends that the Port Commission delegate authority to the Port Authority's Executive Director and authorized representatives of the Executive Director to make routine purchases in an amount not to exceed \$100,000.

Background:

By Minute No. 2022-0524-24, the Port Commission approved a contract with GHD Inc. totaling \$720,393 to provide professional services to support the Asset Management Strategic Improvements Initiative (AMSII) project (Phase II, or the "2022 project scope"). Staff advised the Port Commission at that time that it anticipated requesting future amendments to this professional services contract, pending the performance of GHD, Inc., to extend the term and add scope for beginning implementation of the actions recommended in the 2021 original project scope.

The services provided under the scope of the contemplated amendment and extension would be Year 2 of 5, Phase II of the AMSII project for improving the asset management (AM) and geographic information system (GIS) programs to better align with industry best practices. Additionally, these services would be integrated with the Next Generation Enterprise Resource Planning project, ahead of implementation of the Port Authority's new Enterprise Resource Planning system.

Staff Evaluation/Justification:

Staff recommends the Port Commission approve amending the professional service contract with GHD, Inc.

By Minute No. 2022-0617-02, the Port Commission awarded Weeks Marine Inc. (WMI) the Redfish to Bayport - Alternate B dredging contract (also known as dredging Package 4B/5) for the hydraulic scope of work. Alternate B work consists of dredging Houston Ship Channel Stations 16+000 to 57+000, the Bayport Flare, and Bayport Ship Channel (BSC), with disposal to Three Bird Island Marsh (TBIM).

The BSC and associated Bayport berths have experienced higher than expected shoaling since the last U.S. Army Corps of Engineers (USACE) maintenance dredging contract was completed mid-year 2022, causing a draft restriction to be imposed in May 2023. The USACE has executed an emergency dredging contract to remove the material within BSC. The Port Authority is required to remove the adjacent material within the Bayport Container Terminal (BCT) berths to match the USACE efforts within the BSC.

Expanding the WMI scope to include BCT berth maintenance dredging is the most cost-efficient method to dredge the unexpected maintenance material. At this time, Berths 2, 3, part of 4, and 6 require immediate attention to remain in a nondraft restriction state and prepare for the arrival of the ship-to-shore cranes in July and expected Berth 6 opening in October 2023.

Staff Evaluation/Justification:

Staff has concluded that at this time it would be the most effective approach and in the best interest of the Port Authority for the scope of the Weeks Marine, Inc. contract to be modified to include maintenance dredging at BCT, and so requests that the Port Commission approve an amendment to its contract with the Port Authority as described above.

Background:

Rubber-tire gantry optimization or (RTG-O) is an Navis N4 module that is designed to help optimize manual decision making for placement of RTG cranes. RTG-O helps to answer high level questions including where in the yard should an RTG be deployed, and what RTG should get what job and in what order.

The control room feature of RTG-O would alert the Operations department when an area in the yard is under-or overallocated in terms of RTG crane capacity and then suggest the most optimal RTG to move. The module utilizes advanced algorithms that constantly evaluate every work instruction against the available fleet of working RTG cranes, resulting in a more balanced workload and improved performance.

In total the Port Authority has a current fleet of 116 RTG cranes and a future fleet of 142 in 2024. Having RTG cranes in the right location and allocating work in a balanced manner is critical to terminal performance. The use of RTG-O provides a powerful tool to ensure the RTG fleet is optimized.

The RTG-O module would serve as a technical advancement in daily operations that supports volume growth and optimal service to our customers.

Staff Evaluation/Justification:

Section 60.412 of the Water Code provides that a purchase for an item that can be obtained only from one source is exempt from certain procurement requirements of the Water Code. Port Authority staff has received a written statement from the manufacturer confirming that Navis is the sole source for the RTG-O module.

Staff recommends the Port Commission approve this contract with Navis for the above purchase.

Background:

The Port Authority currently owns thirteen wharf cranes including seven operating at Barbours Cut Terminal and and six at Bayport Container Terminal that are equipped with operator cabins manufactured by Brieda Cabins S.r.l. of Italy. Additionally, three wharf cranes equipped with Brieda cabins are expected to be delivered next month to Bayport Container Terminal. The ability to expedite procurement of spare and replacement parts for these cabins is critical to efficient terminal operation.

Staff Evaluation/Justification:

Section 60.412 of the Water Code provides that a purchase for an item that can be obtained only from one source is exempt from certain procurement requirements of the Water Code. Port Authority staff has received a written statement from the manufacturer confirming that Beck Electric Supply is the sole authorized source for replacement of Brieda parts in the United States.

Staff recommends that the Port Commission award a two-year contract to Beck Electric Supply for the purchase of spare and replacement Brieda cabin parts for wharf cranes at Barbours Cut Terminal and Bayport Container Terminal. Replacement and spare parts would be purchased through this contract as needed to properly maintain wharf cranes and minimize operational downtime.

Background:

In order to facilitate the acquisition and development of a new office building, at its March 20, 2023 meeting the Port Commission took the first step to approve the formation of Port Houston Local Government Corporation (Corporation) organized under subchapter D of Chapter 431 of the Transportation Code.

On April 25, 2023 the application for formation of the Corporation was approved by the Texas Secretary of State, and on May 23, 2023 the organization meeting of the Corporation was held, at which the final form of its certification of formation and bylaws, officer roster, and various banking, audit, and tax matters were approved by its Board of Directors.

The initial draft of an interlocal agreement between the Corporation and the Port Authority, which would provide the Corporation with administrative support was also approved at that meeting. The Board of Directors of the Corporation was informed at that time that staff anticipated that the terms of the agreement might be subject to amendment, based on the financing needs of the Corporation.

The updated form of interlocal agreement is now being brought to the Port Commission for action, and will subsequently be brought to the Corporation for action as well. In addition to providing the Corporation with operational and management assistance, the Port Authority would advance funding to the Corporation up to the amount set forth above, to support the acquisition and development of a new office building for Port Authority employees. The terms of a lease or other arrangement in connection with that use would be subject to future action by the Port Commission and Board of Directors of the Corporation.
