T. Adjourn Meeting

A public meeting of the Port Commission of the Port of Houston Authority of Harris County, Texas was convened on December 10, 2024, at 9:15 a.m., at the Port of Houston Authority Executive Offices, Fourth Floor Boardroom, at 111 East Loop North, Houston, Texas 77029, and via Cisco WebEx. The following commissioners, staff, and counsel were present:

Chairman Campo began his opening remarks by emphasizing that the Houston Ship Channel deepening and widening project (Project 11) continued to make progress. Segment 1B dredging was recently completed, meaning that the channel had been expanded from Galveston Bay through the Bayport Ship Channel. This delivered benefits to the region, enabled safer navigation along the nation's busiest waterway, and enabled more efficient vessel movements through significantly reduced daylight restrictions.

Dredging continued on Segment 1C, the last of the Port Authority-led procurements, and was expected to be completed in the next three to four months. Future segments were to be handled by the U.S. Army Corps of Engineers (Army Corps) with Port Authority support.

Chairman Campo remarked that the Port Commission Community Advisory Council (PCCAC) held its final meeting of the year on December 3, 2024. The PCCAC helped the Port Authority better engage with community stakeholders who had a vested interest in the Port Authority's activities and were in some way connected to its mission. Members of the PCCAC served two-year terms that expired upon the conclusion of the last meeting. A new group of members would serve beginning in 2025.

Chairman Campo highlighted the third annual Community Resource Fair which was held the previous Saturday. This was a free event that provided the community with important resources. There were over 3,000 attendees, nearly 60 Port Authority partners, and services provided related to healthcare and workforce development. There was even a mariachi band comprised of students from Channelview High School.

Commissioner Jones mentioned that he had recently attended a luncheon where it was clear that the Port Authority's objectives were different from everyone else's. Both Chairman Campo and Mr. Jenkins were in attendance and represented the Port Authority well.

Chairman Campo quipped that the luncheon was a success, and he was gently corrected after getting a few of his history dates incorrect.

(2024-1210-01) Chairman Campo called for a motion to approve the minutes of the October 22, 2024 Port Commission meeting. Commissioner Corgey moved for approval, seconded by Commissioner Cloonan. The minutes were approved as written.

(2024-1210-02) Charlie Jenkins, Chief Executive Officer, recognized selected employee milestone anniversaries:

- John B. Etta, Operations Division, 30 years;
- LaMelle D. Hunter, Operations Division, 30 years;
- Stephen W. Baird, Maintenance Division; 20 years; and
- Ryan G. Mariacher, Operations Division, 20 years.

Mr. Jenkins continued with a summary of selected financial and operational yearend matters:

- There was \$136 million on the agenda in awards.
- The Port Authority was awarded more than \$57 million in grant funds in 2024.
 - The grant funds supported various initiatives that benefitted port infrastructure, the environment, and the surrounding communities.
 - A MARAD grant was announced mid-November 2024 in an amount of \$25 million.
 - The goal was to support air quality by reducing dust and truck emissions.
 - It would also be the first step toward improving nearby stormwater drainage systems, benefiting the Port Authority and the community.
- Cargo volumes through the public terminals were strong; the Port Authority
 expected to exceed the prior year's volumes in both container and total
 tonnage.
- The Houston Ship Channel continued to be the number one waterway in the nation in terms of both vessels and volume.
- Project 11 was progressing well.

- There were zero draft restrictions to date in 2024.
- Operational challenges included Hurricane Beryl and the brief International Longshoremen's Association (ILA) work stoppage.
- The Port Commission awarded more than \$480 million to capital projects in 2024, which did not include the investment in Project 11.
- Sustainability efforts continued
 - 40% of the Port Authority's rubber-tired gantry (RTG) crane fleet was comprised of hybrid electric units, which produced less emissions than standard models.
- The Port Authority continued its strong engagement in the community
 - o The Community Grants program awarded 19 different grants.
- Opportunities for small, minority, and women-owned business enterprises (S/MWBEs) surpassed a large milestone more than \$1 billion had been awarded in contracts since the small business program began in 2002.
- There were eight maritime high school programs in seven districts, with 86 graduates in the 2024 class of maritime education.
- A new Strategic Plan was developed and adopted by the Port Commission.
- The Port Authority received the Great Place to Work distinction for the first time.

(2024-1210-03) Appearances

(a) Chairman Campo recognized Captain Keith M. Donohue, Commanding Officer, U.S. Coast Guard Sector Houston-Galveston, who addressed the Port Commission.

Capt. Donohue informed the Port Commission of a recent visit from the Vice Commandant of the U.S. Coast Guard (Coast Guard) and the area commander, during which a boat tour on the MV Sam Houston was taken with cadets.

Capt. Donohue yielded the floor to Rear Admiral Jason Tama, Commander, Coast Guard Cyber Command. Cmdr. Tama was especially excited to hear about the education partnerships that the Port Authority had with the community and the investment it made in the future leaders and future workers.

Cmdr. Tama thanked the Port Authority for the great relationship, adding that the employees at the Port Authority did a great job.

Capt. Donohue resumed the floor. He stated that the Coast Guard Sector Houston-Galveston had won the national partnership education award four years in a row, but despite this achievement, the Coast Guard had never formalized its partnership with the Port of Houston Partners in Maritime Education (PHPME) organization.

Capt. Donohue presented Jacquelin Young-Hall, Maritime Education Program Manager, with a memorandum of understanding with the purpose of representing a joint commitment by the parties to increase the level of academic excellence among students and with the goal of providing increased education opportunities for students enrolled in maritime focused programs.

Commissioner Corgey appreciated the dedication and help of the Coast Guard. The maritime education system was working as there were many new people in apprenticeship programs.

(b) Chairman Campo recognized Joe Jennings, Schiller Institute, who addressed the Port Commission.

Mr. Jennings spoke of the opening of the Yangshan Deep-Water Port, which could already handled 1.5 million twenty-foot equivalent units (TEU), with an expected capacity of 6 million. He added that South America was an alternative to stimulate commerce and create jobs, and that the Port Authority should invest in the region.

(c) Chairman Campo recognized Bridgette Murray, who addressed the Port Commission.

Ms. Murray was a resident of Galena Park located near the Glendale dredge placement site. She thanked the Port Authority for its work in securing the MARAD grant, which included a stormwater drainage plan for the area. There was a lot of work to be done – especially with the City of Houston.

Ms. Murray looked forward to working with the Port Authority on other projects in the future.

Chairman Campo noted that there were no Executive agenda items.

Chairman Campo noted that there were no Business Equity agenda items.

(2024-1210-04) Chairman Campo recognized Leia Wilson, Director, Channel Infrastructure, to provide a report of selected Channel Infrastructure agenda items.

Ms. Wilson provided a few high-level Project 11 updates. As stated earlier, the dredging of Segment 1B had been completed. Working with the Army Corps, the Coast Guard, and the Houston Pilots, the Port Authority hoped to have Segment 1B and Segment 2 officially approved and accepted by the end of 2024. The construction of the Three Bird Island marsh continued with an expected completion by the third quarter of 2025.

Dredging continued on Segment 1C – Bayport to Barbours Cut – and was on both budget and schedule. The expected completion was second quarter of 2025. The Army Corps of Engineers awarded Segment 3; however, there was a bid protest which was tracking to be resolved by January 2025. To date, all Port Authority-led dredging was under budget and ahead of schedule.

Ms. Wilson noted that there were four items on the agenda. Items H2 and H3 were fairly standard renewals and permits. Items H1 was for an extension of an engineering and audit services contract and to expand the contract scope to include the Bayport East End area, which had been considered during the Project 11 feasibility.

Item H4 was approval of a marine construction permit for construction of a Texas Coastal Ocean Observation Network (TCOON) station in Buffalo Bayou, to replace a station lost in a previous storm. TCOON stations collected water levels, wind speed, and salinity levels, among other data, and the station to be built would also include a current meter that would be used by both brown and blue water mariners. The station was to be placed at the confluence of the San Jacinto River and Buffalo Bayou, where the measuring of currents was crucial.

Commissioner DonCarlos asked about the location of the TCOON station, since h was concerned whether it would get in the way since there was a lot of water traffic at the location. Ms. Wilson informed the Commissioner that the station would not interfere with vessel traffic along the channel.

- (2024-1210-09) Chairman Campo recognized Isaac Kyle, Director, Real Estate, to provide a report of selected Commercial agenda items.
- Mr. Kyle announced that the goal of the Real Estate Department was to facilitate acquisitions, dispositions, and lease transactions with the goal of supporting long term benefits to the regional, state, and national economy in support of maritime economic development. The current lease portfolio revenue, year over year, was ahead approximately 8% compared to 2023.

He noted that the Marketing team organized the third annual Houston International Maritime Conference (HIMC) the past year with over 800 attendees.

- Mr. Kyle also provided an industry update. Colliers recently reported that the Houston market had increased absorption and outpaced new supply for the first time in two years. This pointed to a more stable overall market.
- Mr. Kyle stated that Items I1 and I2 were standard lease amendments to extend the terms of two Port Authority leases. Item I3 was for the approval of a contract for the hosting of the 2025 HIMC event. Item I4, I5, and I6 were for ingress and egress access to the Port Authority's Beltway 8 property, which was serving as a dredge material placement area in support of Project 11.

- (2024-1210-16) Chairman Campo recognized Curtis Duncan, Controller, to provide a report of selected Finance agenda items.
- Mr. Duncan explained that the single item on the agenda for Finance was for the approval of the annual fee the Port Authority paid to both the Harris County Appraisal District and the Harris County Tax Assessor-Collector, for services related to appraisals and tax collection, respectively.
- (2024-1210-17) RCA J1 was presented, moved by Commissioner Corgey, seconded by Commissioner Robb. Chairman Campo, and Commissioners Cloonan, Corgey, DonCarlos, Fitzgerald, Jones, and Robb voted Aye. Nays none. RCA J1 PASSED.
- (2024-1210-18) Chairman Campo recognized Rich Byrnes, Chief Infrastructure Officer, to provide a report of selected Infrastructure agenda items.
- Mr. Byrnes announced that there were sixteen items on the Infrastructure agenda for the month with a total request of approximately \$110 million. That brought the yearly total to ninety RCAs totaling \$325 million, including full completion of the seven major projects tracked under capital improvement plan (CIP) Attainment. The major items had a baseline value of \$298 million but were awarded for \$258 million, through prudent negotiations to maximize value for the Port Authority.

In addition to awarding new work, the Port Authority delivered projects at all terminals in 2024, including new container yards at the Bayport Container Terminal and the Barbours Cut Container Terminal, demolition work at the auto terminal, power supply and trench drain projects, and clearing and pre-development of open acreage.

Mr. Byrnes highlighted the Environmental Affairs Department for recognition of its leadership by the Texas Commission on Environmental Quality, while also conducting over one hundred tenant audits and working with communities. The Grants Department added nearly \$60 million in support from state and federal sources.

Mr. Byrnes continued: Project Controls, the Operations Division, and others collaborated to continuously improve processes and tools for how staff managed, tracked, and executed the hundreds of big and small projects in the capital plan. It was a good year overall for the Infrastructure Division.

Mr. Byrnes commented that Items K1, K2, and K3 were all for Container Yard 8 while Item K6 was for Container Yard 1 South, all located at Bayport Container Terminal. When combined, they would add 42 acres of new yard and support areas. Item K5 was for the repair of Wharves 20 and 21 at Turning Basin Terminal. Item K10 was for the clearing of the Greens Bayou Terminal property to help advance about 350 acres of marketable real estate. Item K12 was a success story for business equity as the contractor had worked previously as a subcontractor, but never as a prime. It was now up for award as the prime contractor and held an S/MWBE designation.

Commissioner DonCarlos asked about the company being awarded the contract for Item K5. Mr. Heidt explained that the company had worked with the Port Authority in the past and the current people in charge were different than those who had been there previously.

Commissioner DonCarlos asked where the Memorial Tract property was located. Mr. Byrnes explained that there were two pieces of property adjacent to one another that were referred to as the Memorial Tract. The larger piece was under a conservation easement and was being serviced by Armand Bayou Nature Center, the smaller tract was commercially developable, and the overall property was located south of Bayport Container Terminal.

Commissioner Cloonan was appreciative of the fact that an S/MWBE company was awarded the prime contract.

- Mr. Soares announced that the three wharf cranes that arrived in August had been successfully commissioned and released for operations, which brought the total number of wharf cranes at Bayport Container Terminal to eighteen. Additionally, five new RTG cranes had arrived at Barbours Cut the previous month, bringing the entire fleet up to 147 cranes between the two container terminals, of which nearly 40% were hybrid.

With the opening of the new Maintenance and Repair facility at Barbours Cut Container Terminal, staff now had complete visibility of parts inventory: each terminal could view what other facilities had in stock, which was not possible before, and was a very important milestone in inventory management.

Mr. Soares stated that over 2,000 feet of power cable was being pulled underground at Bayport Container Terminal to restore a power supply relay in support of Container Yard 6 and 7.

Mr. Soares gave a shoutout to the machine work staff at Turning Basin Terminal Central Maintenance. They worked Thanksgiving weekend in support of crane operations and replacement of electrical service with no disruption to operations.

Mr. Soares remarked that there was a single agenda item for his division: a contract for the purchase of two manlift machines, one for the Bayport Container Terminal and one for the Turning Basin Terminal. The purchases were needed due to increased demand at the terminals.

(2024-1210-37) Chairman Campo recognized Ryan Mariacher, Chief Port Operations Officer, to provide a report of selected Port Operations agenda items.

Mr. Mariacher reported that while the multipurpose facilities continued to be down, there was good news on the horizon: steel tonnage was up 37% for the month vs. October 2023, which increased total growth on the year to just under 1.5%. Overall, general cargo tonnage decreased slightly, down just over 8% for the year, but dry bulk tonnage improved last month, with the bulk plant and grain elevator driving the numbers forward.

Container volumes rebounded dramatically after October 2024, with the result being a 9% increase for the year in total TEU. The big story for the month was the high export volumes, up over 38% compared to October 2023. The loaded import/export split was currently at 55% to 45%, respectively. The Port Authority was on pace to surpass four million TEU for the year.

Mr. Mariacher reported that the express pass program at the truck gates had been fully deployed, and in the previous week the Port Authority surpassed 95% of truck pretransactions in advance of arrival. This provided staff with short term forecasts to help improve equipment deployments resulting in better service on peak days.

Mr. Mariacher highlighted Item M1, the annual request to issue stevedore licenses – a total of fourteen. Item M2 was a request to amend two terminal chassis leases. There had been a regional impact from the post Covid-19 pandemic supply chain challenges, primarily in the chassis shortage area, and to support continued growth and safe handling of primarily refrigerated cargos, the Port Commission had approved three separate equipment leases in 2022. Because the equipment was not available at the time and slowly trickled in, staff was now requesting additional funds to satisfy the entirety of the term lease.

Commissioner Fitzgerald asked what the average turn time was with the new express pass being implemented and Mr. Mariacher answered that it was below 42 minutes, adding that the real benefit was having advanced visibility on peak days, resulting in a reduction in queue times.

Commissioner DonCarlos wondered if there was still a chassis issue, and thought the critical shortage occurred in 2022. Mr. Mariacher responded that much had changed since the shortage, but the Port Authority still had agreements it needed to work through.

Ms. Shaver highlighted the first-ever middle school maritime field day that was held in November. This was an initiative to focus on the middle school pipeline of potential students interested in the maritime industry. More than 200 students and teachers attended representing fourteen middle schools from five area school districts.

As mentioned previously, the current iteration of the PCCAC was wrapped up and a new group of members would be coming on in 2025. The Port Authority was in the middle of its Season of Giving which culminated in its third annual Community Resource Fair. Other programs included the Thanksgiving project that resulted in hundreds of meals delivered to families in need, the Port Authority "giving tree," and the Police Department's Blue Santa.

Ms. Shaver remarked that staff was very excited to have increased the impact of the Community Resource Fair; there were over 3,000 attendees.

Ms. Shaver highlighted the four agenda items: Item N1 was to authorize funding for the payment of claims from the Port Authority's self-funded group medical benefits program, Items N3 was for the purchase of office supplies, and Item N4 was to adopt the proposed 2025 Incentive Award Plan.

Specifically, the 2024 network refresh initiative was with regard to the master plan, and network devices such as routers and switches were vital to operations and minimizing unplanned downtime.

Background:

The Port Authority is currently carrying out Project 11, the eleventh major Houston Ship Channel (HSC) improvement project referred to as the Houston Ship Channel Expansion Channel Improvement Project (HSC-ECIP), which would widen the channel by 170 feet (from 530 feet to 700 feet) along its Galveston Bay reach, deepen and widen upstream segments, make other safety and efficiency improvements, and craft new environmental features. The work of the HSC-ECIP is divided into segments, and procurement of the pre-construction, engineering, design, construction, and other general services required for each segment is divided into divisible construction packages.

With the Port Authority completing its Port Authority-led portion of Project 11 by the end of 2025, six construction packages remain to be completed by the U.S. Army Corps of Engineers:

- 1. Segment 3, Package 7, Barbours Cut Channel
- 2. Segment 4, Package 8A, East 2 Clinton placement area
- 3. Segment 4, Package 8B, Beltway 8 placement area
- 4. Segment 4, Package 9, Boggy Bayou to Sims Bayou
- 5. Segments 5/6, Package 10/11, Glendale and Filterbed placement areas
- 6. Segment 5/6, Package 12, Sims Bayou to Turning Basin

By Minute Nos. 2020-0428-39, 2020-0730-25, and 2022-0617-04, the Port Commission awarded Freese & Nichols, Inc. (FNI) contract amendments to provide continued engineering and auditing services for items (1) through (6) of the list above for a total amount of \$1,400,000. Port Authority staff authorized three no-cost amendments to extend the contract term through December 31, 2026.

Portions of the proposed Bayport Container Terminal East End project development were originally included in the Project 11 Feasibility Study evaluation. Key members of the FNI team were involved in the Project 11 Feasibility Study and therefore have intimate knowledge of Project 11, HSC, Bayport

Ship Channel, and the proposed Bayport Container Terminal East End project development.

The proposed amendment would be the sixth amendment to the contract. It would extend the term of the contract beyond December 31, 2026. It would also authorize FNI to provide engineering and auditing services for the proposed Bayport Container Terminal East End project development at no additional cost to the Port Authority.

Staff Evaluation/Justification:

Port Authority staff has determined that FNI is the most highly qualified firm to provide continued engineering and auditing support services to complete Project 11 and support the proposed Bayport Container Terminal East End project development.

The Texas General Land Office (TGLO), Port Authority File No. 2024-0283, has applied for a marine construction permit for construction of a Texas Coastal Ocean Observation Network (TCOON) station, i.e., a wooden data collection platform in the San Jacinto River, adjacent to the Nathaniel Lynch Survey, A-44.

The TCOON is a collection of high-level coastal data stations that provide real-time measurements of oceanic and meteorological conditions along the entire length of the Texas coast. Staff is informed that these measurements provide the foundational data by which the junction between ocean and land is computed, marine navigation is supported, and emergency storm preparedness models are developed.

The Lynchburg TCOON Station was first installed in 1995 to collect water level data with the intent of producing water level datums in support of TGLO surveying activities in the region. The structure was later rebuilt as a wooden four-pile platform in 2010 near the proposed location. This station provided critical water level and metrological data to private and public entities until it was destroyed during the passage of Hurricane Harvey in 2017. The TGLO has informed staff that proposed location is critical due to the historical collection of data at this site as well as the established benchmark network of five deep rod benchmarks installed on the adjacent property. In addition to the water level and meteorological data, this platform would also house a current data meter to collect water currents near the area.

Staff Evaluation/Justification:

The application was reviewed and approved by the Port Authority's Channel Infrastructure Real Property department. The application fee and as-built deposit have been waived.

The Harris County Appraisal District provides appraisal services to the Port Authority in connection with its ad valorem taxes. As provided in Section 6.06(d), Texas Property Tax Code, "each taxing unit [e.g., the Port Authority] participating in the [appraisal] district is allocated a portion of the amount of the budget equal to the proportion that the total dollar amount of property taxes imposed in the [appraisal] district by the unit for the tax year in which the budget proposal is prepared bears to the sum of the total dollar amount of the property taxes imposed in the [appraisal] district by each participating unit for that year."

In addition, pursuant to statute, the Harris County Tax Assessor-Collector is charged with the assessment and collection of taxes levied on behalf of the Port Authority within the Port Authority's jurisdiction, and receives compensation for such services as agreed to by the Port Commission and Harris County Commissioners Court. In July 2007, the Harris County Commissioners Court adopted a fee schedule, which remains in use at present, such that each taxing unit is charged property tax collection fees at the rate of \$1.10 per parcel plus \$0.0275 per hundred dollars of taxable valuation.

Staff Evaluation/Justification:

The Harris County Appraisal District has indicated that the estimated cost allocation to the Port Authority for appraisal services to be provided for fiscal year 2025 is under \$405,000.

Background:

The Port Authority currently owns two telescopic boom manlifts in operation at its Bayport Container Terminal, and one at its Turning Basin Terminal. These units are utilized daily by Maintenance department personnel to service and maintain terminal lighting, buildings, gates, eighteen wharf cranes, and seventy-eight rubber-tired gantry (RTG) cranes. The manlift at Turning Basin Terminal lacks the articulating capabilities needed to meet the high demand for such equipment. As a result, the Port Authority has rented articulated boom manlifts from various rental companies for approximately one year. Staff has determined that in leu of rental, that an articulated boom manllift be purchased for Turning Basin Terminal. Additionally, twelve RTG cranes were recently delivered to Bayport Container Terminal, increasing the fleet from sixty-six to seventy-eight units, resulting in the increased demand for an additional manlift at Bayport Container Terminal.

Staff Evaluation/Justification:

The Director of Procurement Services has determined that procuring both the telescopic boom and self-propelled articulated boom manlifts through the BuyBoard program is the method that both satisfies competitive purchase requirements and provides the best value to the Port Authority.

The Maintenance department has determined that the best availability, price, and contract term for the manlifts needed are provided by Briggs Equipment under the pricing schedule obtained from that vendor's contract with BuyBoard Program and is therefore recommending this purchase.

Accordingly, staff recommends that the Port Commission approve this best value determination and contract.

Background:

The Port Commission, at its August 2, 2022 meeting, approved a chassis lease with Interpool, Inc. dba TRAC Intermodal as lessor for a two-year term for 213 chassis with a total base rent not to exceed \$699,705, each pursuant to Water Code Section 60.4035 as an emergency procurement and Local Government Code Section 271.005. The Port Authority also entered into a chassis lease as of June 21, 2022, with Milestone Equipment Company LLC, as lessor, for a five-year term for 700 chassis with annual base rent not to exceed \$2,184,525 pursuant to Water Code Section 60.4035 as an emergency procurement and Local Government Code Section 271.005.

Port Authority staff approved the original purchase order amounts for these leases contemplating that all chassis for each lease would be delivered in one batch. However, the chassis for each lease was provided incrementally, leading to unanticipated partial payments paid by the Port Authority in the months leading up to full receipt of the entire chassis pool for each lease. As a result, staff now requests additional funding for these leases.

Staff requests to increase the purchase order for the lease with (i) Interpool, Inc. dba TRAC Intermodal by \$69,571 for a new total of \$769,276, and (ii) increase the purchase order for the lease with Milestone Equipment Company LLC by \$293,436 for a new total of \$11,216,061.

Staff increased the purchase order for the TRAC lease in November 2024 by \$47,165 for charges incurred in October and November 2024. Staff is now requesting to increase the purchase order for the TRAC lease by an additional \$58,310 for the remainder of the lease.

Background:

By Minute No. 2022-1206-50, the Port Commission awarded a contract to Gallagher Benefits Services, Inc. to provide employee benefits consulting services, including assisting in: the development of requests for proposals for group insurance coverages; evaluation of proposals; negotiation of renewal rates; and recommendations on provider selections.

In September 2018, after having reviewed proposals and analyzed the costs of a self-funded program compared to a fully insured medical program, the Port Authority proceeded with the implementation of a self-funded group medical benefits program administered with Aetna as the Third-Party Administrator (TPA).

The Pension and Benefits Committee was given a summary of the status of the 2023 medical program at its September 24, 2024 meeting. Gallagher and staff recommended, and the Pension and Benefits Committee concurred, that the Port Authority continue with the self-funded program for calendar year 2025.

Staff Evaluation/Justification:

The Port Authority's open enrollment period for calendar year 2025 occurred from November 18 to December 3, 2024. Based upon the enrollment information and the review of historical claims data, staff, and Gallagher recommend that \$17,000,000 be reserved for the self-insurance account to pay for all covered medical and pharmaceutical claims for calendar year 2025 from the Port Authority's self-funded group medical insurance program for active employees, retirees who are not Medicare-eligible, and their dependents.

The payment of covered claims from the dedicated funds would be administered by Aetna pursuant to its third-party administration services agreement with the Port Authority.

Background:

By Minute No. 2017-1023-48, the Port Commission authorized a two-year agreement with LinkedIn Corporation (LinkedIn) for recruiting and trade marketing access and services.

By Minute Nos. 2020-0128-49 and 2021-1207-54, the Port Commission authorized respectively additional two- and three-year agreements with LinkedIn.

LinkedIn provides visibility to what it claims to be the world's largest professional network, with over 1 billion members worldwide. The Port Authority has utilized LinkedIn for the past eight years as a personnel outreach and recruitment tool and has received thousands of applications through LinkedIn, resulting in approximately 42% of its professional hires through this network.

The Port Authority's existing agreement with LinkedIn allows the Port Authority to post seven jobs at a time, customize the content on the Port Authority's LinkedIn webpage, and use recruiting tools for finding, connecting with, and managing candidates. The Port Authority currently has over 45,000 LinkedIn followers.

Section 60.412 of the Water Code provides that a purchase for an item that can be obtained only from one source is exempt from certain procurement requirements of the Water Code. Port Authority staff has received a written statement from LinkedIn confirming that it is the sole source for access to LinkedIn's professional network.

Staff Evaluation/Justification:

LinkedIn Corporation is offering through its platform and services Career Pages (Enterprise Basic Package) custom content on the LinkedIn profile page and preferred placement on company page, seven preferred Job Slots at a time, and Corporate Recruiter, which allows for 150 InMails per month and unlimited network searches.

In comparing LinkedIn results with the results of other recruiting sites, staff believes LinkedIn has performed very well and is well worth the investment.

Staff recommends the Port Commission approve this contract with LinkedIn Corporation.

The ESC contract with Epic authorizes Epic to designate one or more third parties to fulfill customers' purchase orders pursuant to conditions set out in the ESC contract; each such third party is defined in the ESC contract as an authorized distributor. Office and Furniture Companies of Texas LLC, doing business as Greater Houston Office Products (OFC), is one such identified third party under the contract between ESC and Epic.

Staff Evaluation/Justification:

The Director of Procurement Services has determined that procuring office supplies, toner cartridges, and copy machine paper through OMNIA is the method that both satisfies competitive purchase requirements and provides best value to the Port Authority.

The Office Services department has determined that the best availability, price, and contract terms for the items needed are provided by OFC under the pricing schedule obtained from the contract with OMNIA, and is therefore recommending this purchase.
