A public meeting of the Port Commission of the Port of Houston Authority of Harris County, Texas was convened on January 28, 2025, at 9:15 a.m., at the Port of Houston Authority Executive Offices, Fourth Floor Boardroom, at 111 East Loop North, Houston, Texas 77029, and via Cisco WebEx. The following commissioners, staff, and counsel were present:

Chairman Campo began his opening remarks by commending Port Authority staff for their ability to handle challenges, specifically the winter weather of the previous week that caused operations to be suspended for approximately 48 hours. Staff and International Longshoremen's Association (ILA) partners worked hard, the Port Authority provided Saturday gate hours, and working together the backlog was effectively overcome.

Chairman Campo congratulated Commissioner Fitzgerald on his recent reappointment as commissioner. Commissioner Fitzgerald has been a commissioner since 2013 but has dedicated his entire career to the region's maritime industry.

Chairman Campo also noted that Commissioner Corgey would not be seeking reappointment, after over a decade as a member of the Port Commission. Commissioner Corgey has also spent many decades in the maritime industry; his advocacy on behalf of the men and women who work in the maritime industry has helped shape the growth of the port.

He additionally observed that Commissioner Robb had been reappointed as a Port Commissioner.

Finally, Chairman Campo remarked that he had been reappointed as Chairman of the Port Commission earlier in the month, and that he would continue his commitment to collaborating and working in partnership with his fellow commissioners, the ILA, the U.S. Coast Guard, the Houston Pilots, industry, users, customers, community, and all other stakeholders for the good of the region.

(2025-0128-01) Chairman Campo called for a motion to approve the minutes of the November 12, 2024, and the December 10, 2024, Port Commission meetings. Commissioner Fitzgerald moved for approval, seconded by Commissioner Cloonan. The minutes were approved as written.

(2025-0128-02) Charlie Jenkins, Chief Executive Officer, presented a summary of selected 2024 financial and operational matters; and other year-end accomplishments:

- 2024 included record-breaking total tonnage at the public facilities, up 6% over 2023, at 53 million tons.
- Twenty-foot equivalent units (TEU) were up 8% in 2024, for a total of 4.14 million
  - Loaded exports were up 8%, primarily resins.
  - o Loaded imports were up 6%, primarily consumer goods.
  - Loaded reefer imports were up 15%.
- The Port Authority had the largest-ever container vessel call at its facilities the CMA CGM Cassiopeia, a 1,190 foot vessel in regular rotation.
- Several gate records were set in 2024, including a combined terminal daily record, a Bayport Container Terminal daily record, and a Barbours Cut Container Terminal daily record.
  - o 2024 records had all been broken already in 2025.
- Total capital investments in 2024 totaled \$630 million (including \$148 million for Project 11 alone).
  - 100% of the Capital Improvement Plan \$372 million was awarded.
- The Maintenance Division commissioned 31 new hybrid rubber-tired gantry (RTG) cranes at Barbours Cut and Bayport Container Terminals, and three new ship-to-shore (STS) cranes at Bayport Container Terminal.
- The NXGEN Wireless initiative was providing enhanced wireless coverage and performance at the container terminals.
- Great progress was made on Project 11.
  - o The last Port Authority-led contract commenced (Segment 1C).
  - o Three contracts were completed.
  - o Federal acceptance of three mitigation features was achieved.
  - Additionally, \$67 million in federal earmarks were obtained for Project 11.
- The Houston Ship Channel was free of draft restrictions between October 2023 and December 2024 an achievement that had not seen in well over a decade.
- WRDA 20241 passed late in the year: the measure extended the federal dredging cost share responsibility from 50 feet to 55 feet for Construction

- and Operations & Maintenance, and authorized a feasibility study for Project 12.
- The Fire Department enhanced emergency response capabilities through robust partnerships and advanced training such as high-angle rescue drills.
- Maritime economic development in the region was a point of emphasis.
  - Staff management of Foreign Trade Zone (FTZ) 84 added a record nine new sites and increased its allowable activation limit with the U.S. Foreign Trade Zones board from 2,000 to 3,000 acres, further boosting the economy and facilitating international trade.
  - FTZ 84 employed approximately 9,000 people and brought in merchandise of up to \$50 billion annually.
- The Port Authority engaged more than 60,000 community members through multiple outreach efforts, including the third annual Community Resource Fair, with over 3,000 attendees.
- The Port Authority awarded \$181.1 million to 521 small businesses that participated in its programs, and also surpassed a milestone of \$1 billion in awards since the launch of the Small Business Development Program in 2002.
- The Port Authority's maritime education outreach expanded to eight maritime high school programs in seven districts resulting in 86 graduates in the 2024 class, and two significant firsts were achieved:
  - A unique academic partnership between Chevron and Austin High School, boosting workforce access and funding for the school's maritime program.
  - A Memorandum of Understanding was entered into with the Coast Guard to enhance engagement and development opportunities for Houston's future maritime workforce.
- The Port Authority was recognized by the Texas Commission on Environmental Quality (TCEQ) and the North American Marine Environment Protection Association with awards for its work in pollution prevention, sustainability, maritime education, and Project 11 environmental stewardship.
  - o It also achieved recertification by the International Standards Organization for Environmental Management, continuing a tradition started in 2002.
- Grant awards totaling \$57 million were obtained for projects that improved port efficiency, emission reduction, and community benefits.
- The NXGEN ERP project implementation began, which was expected to provide more efficient and effective solutions to managing business-critical functions in Human Resources, Finance, Real Estate, Asset Management, Maintenance, and Capital Projects.
- Finally, the Port Authority received the Great Place to Work designation for the first time in 2024.

- The designation should to help bolster recruitment and was a positive indication of momentum in improving the employee experience.
- o Mor important than the designation was the fact that Port Authority employees felt that it was a great place to work.

Mr. Jenkins stressed that there were many more things he could have highlighted, but the list gave a snapshot into last year's accomplishments. He thanked the Port Commission for its support, and added that staff looked forward to a great 2025.

# (2025-0128-03) Appearances

- (a) Chairman Campo recognized Cleophus Sharp, Achieving Community Tasks Successfully (ACTS), who addressed the Port Commission.
- Mr. Sharp spoke on behalf of the port communities that lived daily with unsafe conditions that affected the basic human rights to breath clean air. The Port Commission worked hard to improve the economic conditions and sustainability of the port but the communities bore the brunt of the poor air quality produced by chemical plants in the surrounding area.
- Mr. Sharp stated that his father was once a member of the Port Commission and represented the community, and unless one lived in the community, one would never fully understand to watch a toddler or grandparent struggle to catch their breath.
- Mr. Sharp requested that a member of the frontline community be appointed to the Port Commission someone who had personal experience of what the community endured on a daily basis.
- (2025-0128-04) Chairman Campo recognized Erik Eriksson, Chief Legal Officer, to provide a report of selected Executive agenda items.
- Mr. Eriksson explained that the single item on the agenda was for an extension of the Port Authority's contract for offsite record storage. The contract amount was slightly higher, as a larger portion of records were expected to be stored offsite in the coming years.
- (2025-0128-05) RCA F1 was presented, moved by Commissioner Fitzgerald, seconded by Commissioner Robb. Chairman Campo, and Commissioners Cloonan, Corgey, DonCarlos, Fitzgerald, Jones, and Robb voted Aye. Nays none. RCA F1 PASSED.

Chairman Campo noted that there were no Business Equity agenda items.

(2025-0128-06) Chairman Campo recognized Lori Brownell, Chief Channel Infrastructure Officer, to provide a report of selected Channel Infrastructure agenda items.

Ms. Brownell remarked that there were currently two draft restrictions in place at the container terminals, adding that the Port Authority was working closely with the U.S. Army Corps of Engineers to get them resolved. Thankfully the restrictions had not impacted many vessels.

Mr. Jenkins added that the restrictions had not been caused by a lack of federal funding, but rather from a procurement issue on a contract that had been appealed and awaiting resolution from the Department of Justice.

Ms. Brownell reported that the Army Corps of Engineers accepted all of Segment 1B, and the Coast Guard was in the process of relocating the aids to navigation so that all of Galveston Bay would be open to Bayport, which would save approximately two hours of transit time.

Ms. Brownell noted that Items H1 and H2 were contract extensions that related to Project 11, and Items H3 through H9 were for channel real property.

Commissioner DonCarlos voiced concern regarding agenda Item H3, a submerged land lease in Old River. He worried that there was quite a bit of water traffic in the area and navigation could be an issue. However, he was assured that, although the area was crowded, there was enough space to safely navigate the area.

Commissioner DonCarlos also commented that the community was supportive of ExxonMobil, which was constructing a dock to which Items H5 and H6 pertained to.

Finally, he asked staff to address Item H9, as he wanted to make sure that protective measures were put into place along the bridge so that people could not perform acts that could cause bodily harm to themselves.

- Mr. Atabuatsi remarked that both agenda Items were real estate matters. Item H1 was to extend the term of a lease while H2 was to ratify a month-to-month lease.
- (2025-0128-17) RCA II was presented, moved by Commissioner Fitzgerald, seconded by Commissioner Cloonan. Chairman Campo, and Commissioners Cloonan, Corgey, DonCarlos, Fitzgerald, Jones, and Robb voted Aye. Nays none. RCA II PASSED.

(2025-0128-18) RCA I2 was presented, moved by Commissioner Fitzgerald, seconded by Commissioner Cloonan. Chairman Campo, and Commissioners Cloonan, Corgey, DonCarlos, Fitzgerald, Jones, and Robb voted Aye. Nays none. RCA I2 PASSED.

(2025-0128-19) Chairman Campo recognized Curtis Duncan, Controller to provide a report of selected Finance agenda items.

Mr. Duncan explained that representatives of the Port Authority's auditor, Forvis/Mazars, were in attendance to present the firms findings on the Port of Houston Authority Restated Retirement Plan (Plan). Mr. Duncan yielded the floor to Angela Dunlap, Assurance Partner, and Erica Brown, Assurance Senior Manager, for a report on their findings.

Ms. Dunlap detailed the findings of the audit on the Plan. An unmodified opinion was issued that found no internal control matters.

Ms. Brown further detailed the findings, a full report of which was given to the Port Commissioners. The Port Authority's financial statements for the Plan were in order and conformed to generally accepted accounting principles (GAAP) standards. Two areas to which particularly close attention was paid were management override of controls and benefit payments. The benefit payments were a big risk area, so employees were randomly checked to make sure all proper payments were made correctly; additionally, the qualitative aspects were looked at to ensure everything was reasonable. Nothing unusual was noted.

Ms. Brown concluded that the overall audit was great.

Chairman Campo remarked that typically the auditors would present first to the Audit Committee, then to the Port Commission. However, the schedule for the day had the Port Commission meeting first, followed by the Audit Committee. Additional discussion regarding the audit was anticipated in the Audit Committee meeting.

(2025-0128-20) RCA J1 was presented, moved by Commissioner Jones, seconded by Commissioner DonCarlos. Chairman Campo, and Commissioners Cloonan, Corgey, DonCarlos, Fitzgerald, Jones, and Robb voted Aye. Nays none. RCA J1 PASSED.

(2025-0128-21) Chairman Campo recognized Rich Byrnes, Chief Infrastructure Officer, to provide a report of selected Infrastructure agenda items.

Mr. Byrnes reiterated many of the achievements that pertained to the Infrastructure Division which were earlier noted by Mr. Jenkins. He added that a recent grant that had not been mentioned was a \$25 million award for a hydrogen fueling station. However, the grant funding was currently on pause, pending evaluation by the federal government.

In 2024, \$374 million worth of capital projects had been completed, many of which had been awarded in prior years. Approximately \$800 million in awards were still a work in progress, and thirty more projects were expected to be brought for approval, totaling about \$232 million.

Mr. Byrnes announced that the Texas Transportation Forum convention have just started, which the Port Authority was attending, where it moderated a panel titled "Roadblocks to Freight," to discuss the various issues surrounding truck congestion.

Mr. Byrnes brought only one item for approval, a change order for a roofing repair contract.

(2025-0128-22) RCA K1 was presented, moved by Commissioner Corgey, seconded by Commissioner Jones. Chairman Campo, and Commissioners Cloonan, Corgey, DonCarlos, Fitzgerald, Jones, and Robb voted Aye. Nays none. RCA K1 PASSED.

(2025-0128-23) Chairman Campo recognized Paulo Soares, Chief Port Maintenance Officer, to provide a report of selected Port Operations agenda items.

Mr. Soares shared a few 2024 Maintenance Division highlights. The container terminal STS cranes worked for over 85,000 hours throughout the year with an uptime of 99%, and RTG cranes worked similar hours with only a slightly less uptime – about 96%.

Mr. Soares noted there were six items on the agenda for Maintenance. Item L1 pertained for elevator repair and maintenance at the Port Authority facilities while Item L5 was for the purchase of spare and replacement parts for festoon systems for wharf cranes.

Commissioner DonCarlos asked if, for Item L6, it would ever be feasible for the Port Authority to purchase its own backup generators instead of renting them. Mr. Jenkins explained that the flexibility of renting a mobile unit currently saved money, but staff would look into the feasibility of purchasing one.

- Mr. Shaffner noted there were two items on the agenda. Item M1 was a maintenance and support services contract for services related to terminal operating systems. Item M2 was maintenance of the Marine Terminal Position Detection Software System at the container terminals.

Commissioner Corgey moved for staff's ranking of vendors and award a contract to the top-ranked proposer: staff ranking first, DSP America Inc.; second, Navis LP; and third, Bunnell Enterprises dba Total Network Solutions, seconded by Commissioner Jones. Chairman Campo, and Commissioners Cloonan, Corgey, DonCarlos, Fitzgerald, Jones, and Robb voted Aye. Nays none. RCA M1 PASSED.

Ms. Aguirre highlighted that the Community Relations Department engaged with over 80,000 people in 2024, an impressive accomplishment that included the help of many other Port Authority departments.

Looking ahead, the Community Grants Program would officially kick off on February 1, 2025, and the request for proposals for the Sam Houston boat replacement was currently being worked on; the plan was to bring an award request to the Port Commission in March.

Ms. Aguirre explained that Item N1 was for a community investment and engagement strategy. The Port Authority would be the first port in the nation to do such a thing on the scale and magnitude detailed in the plan, which would devise a strategy to help the Port Authority look at the way it engaged and invested in communities and the way that it partnered with industry.

#### Background:

By Minute No. 2020-0128-05, the Port Commission authorized an agreement with VeriTrust Corporation (VeriTrust) for offsite storage of the Port Authority's business records. The initial term of the contract was for five years at a cost not to exceed \$300,000, with an option to renew for an additional five years at a one-time 4% increase in fees.

The initial term will expire on February 28, 2025.

#### Staff Evaluation/Justification:

Staff has reviewed the contract option for a five-year extension and found it continues to be fair and reasonable, with a one-time 4% increase in fees from those in place during the initial term.

VeriTrust has continually met its obligations under the agreement and demonstrated strong customerfocused service since becoming the Port Authority's offsite storage provider. Since VeriTrust is the incumbent provider, the physical records would remain in their current location and the high-quality service is expected to continue. The Port Authority is currently carrying out Project 11, the eleventh major Houston Ship Channel (HSC) improvement project referred to as the Houston Ship Channel Expansion Channel Improvement Project (Project 11), which is widening the channel 170 feet (530 feet to 700 feet) along its Galveston Bay reach, deepen and widen upstream segments, make other safety and efficiency improvements, and craft new environmental features. The work of the HSC-ECIP is divided into segments, and procurement of the pre-construction, engineering, design, construction, and other general services required for each segment is divided into divisible packages.

With the Port Authority completing its Port Authority-led portion of Project 11 by the end of 2025, six construction packages remain to be completed by the U.S. Army Corps of Engineers:

- 1. Segment 3, Package 7, Barbours Cut Channel
- 2. Segment 4, Package 8A, East 2 Clinton placement area
- 3. Segment 4, Package 8B, Beltway 8 placement area
- 4. Segment 4, Package 9, Boggy Bayou to Sims Bayou
- 5. Segment 5/6, Packages 10/11, Glendale and Filterbed placement areas
- 6. Segment 5/6, Packages 12, Sims Bayou to Turning Basin

By Minute Nos. 2021-1012-07, 2022-0617-05, 2023-0320-19, and 2024-0229-13, the Port Commission awarded the Joint Venture contract amendments to provide continued engineering, design, project coordination, and other general services for Project 11 for a total amount of \$37,277,020. # **Background:**

Exxon Mobil Corporation, Port Authority File No. 2024-0324, has applied for a marine construction permit for a materials offloading facility, consisting of a bulkhead, barge dock, dolphins, and dredged area to -20.0 feet Mean Lower Low Water plus 2 feet of overdraft, extending into Scott Bay, adjacent to the James Strange Survey, A-7.

The purpose of the proposed project would be to provide a materials offloading dock facility to allow the offload of large equipment and components from barges accessible to the Houston Ship Channel destined to the western side of the ExxonMobil Baytown Complex for future expansion. The dredge basin would be approximately 5.23 acres, removing approximately 100,000 cubic yards of dredged material and the dock structure would total approximately 26,250 square feet.

Six vendors downloaded the project materials from BuySpeed.

# **Staff Evaluation/Justification:**

On December 19, 2024, two CSP responses were received, opened, and publicly read. The responses were reviewed and evaluated by staff in accordance with the published selection criteria. Staff identified the following vendors, listed in order of ranking, as providing best value for the required service:

Port Authority staff has received a written statement from the manufacturer confirming that Beck Electric Supply is the sole authorized source for the replacement of Brieda parts in the United States.

Safety devices on these elevators are proprietary and have expiration dates which necessitate periodic replacement. The current purchase order is set to expire in February 2025.

#### Background:

By Minute No. 2021-0928-48, the Port Commission awarded a three-year contract to Conductix, Inc. dba Conductix-Wampfler in the amount not to exceed \$750,000 for the purchase of spare and replacement parts for Conductix-Wampfler festoon systems for wharf cranes at Barbours Cut Terminal and Bayport Container Terminal. The current contract term has expired with less than 20% of funds remaining.

The Port Authority currently owns twenty-two wharf cranes that are equipped with Conductix-Wampfler festoon systems for transmission of power and control to operator cabins. Given the importance festoon systems have in container crane operations, it is advantageous to have a contract in place to purchase spare and/or replacement parts as needed in order to minimize crane downtime.

# **Staff Evaluation/Justification:**

Section 60.412 of the Water Code provides that a purchase for an item that can be obtained only from one source is exempt from certain procurement requirements of the Water Code. Port Authority staff has received a written statement from the manufacturer confirming that Conductix, Inc. dba Conductix-Wampfler is the sole source for captive replacement Conductix-Wampfler parts in the United States.

Staff recommends that the Port Commission award a three-year contract with Conductix, Inc. dba Conductix-Wampfler for the purchase of spare and replacement parts for Conductix-Wampfler festoon systems on wharf cranes at Barbours Cut Terminal and Bayport Container Terminal.

# **Background:**

By Minute No. 2022-0802-44, the Port Commission awarded a three-year contract to United Rentals, Inc. in the amount not to exceed \$300,000 for the rental of emergency power generation for Barbours Cut Terminal, Bayport Container Terminal, and Turning Basin Terminal, using a Sourcewell cooperative purchase program contract.

United Rentals, Inc. would provide generators and reefer plugs on an emergency and temporary basis as needed by the terminals. This contract is necessary for routine maintenance and/or to continue uninterrupted vessel operations.

#### **Staff Evaluation/Justification:**

The Director of Procurement Services has determined that procuring the three-year purchase agreement for emergency or temporary rental power generation-related services through a Sourcewell cooperative purchase program contract is the method that both satisfies competitive purchase requirements and provides the best value to the Port Authority.

The Maintenance department has determined that the best availability, price, and contract term for the items needed are provided by United Rentals, Inc. under the pricing schedule obtained from that vendor's contract with Sourcewell cooperative purchase program and is therefore recommending this purchase.

Accordingly, staff recommends that the Port Commission approve this best value determination and contract.

# Background:

By Minute No. 2019-0924-45, the Port Commission awarded a contract to Kalmar USA Inc to implement and maintain a marine terminal position detection software system for use at Port Authority container terminals. The Position Detection Software System improves yard crane and overall terminal efficiency with improved inventory integrity by completing real time container position updates. Ongoing maintenance and support of the Kalmar position detection system can only be provided by Kalmar USA Inc and therefore the procurement method is sole source.

The contract describes the year-to-year maintenance services that are required to be performed and sets forth the maintenance fee for each one-year maintenance term. The fee is based on the total number of cranes using the position detection system.

# **Staff Evaluation/Justification:**

Section 60.412 of the Water Code provides that a purchase for an item that can be obtained only from one source is exempt from certain procurement requirements of the Water Code. Port Authority staff has received a written statement from the manufacturer confirming that Kalmar USA Inc is the sole authorized source of the position detection software system in the United States.

# Background:

Motorola Land Mobile Radio (LMR) equipment, including handheld, mobile, and base stations, is used daily by Port Authority maintenance and operations personnel, crane operators, and clerks to accomplish daily tasks safely and efficiently. The Port Security and Emergency Operations Division, including contract security, police, and fire departments, uses Motorola LMR equipment as well, to maintain security at all terminals and respond to incidents and other emergencies. Authentic Motorola parts and accessories are required to service the LMR equipment which comprise the vast majority of the approximately 1,800 radios in use.

The Procurement Services department has determined that procuring LMR equipment through the Houston-Galveston Area Council's cooperative purchase program is the method that both satisfies competitive purchase requirements and provides the best value to the Port Authority and staff has determined that the best price for this equipment can be offered in this fashion.

# **Background:**

Liquid Crystal Display (LCD) monitors are also procured using this method because LCD monitors are not included in the purchase of a new computer, and existing monitors can be reused with a new or replacement computer.

# **Staff Evaluation/Justification:**

The Procurement Services department has determined that procuring miscellaneous computer parts and accessories, through OMNIA Partners is the method that both satisfies competitive purchase requirements and provides best value to the Port Authority.

The Information Technology department has determined that the best availability, price, and contract term for the item needed is provided by CDW Government LLC under the pricing schedule obtained from that vendor's contract with OMNIA Partners and is therefore recommending this purchase.

Accordingly, staff recommends that the Port Commission approve this best value determination and contract.
