Instructions to Applicant**

This application is to be used to request a lease for barge fleeting or barge staging over submerged lands owned and managed by the Port Authority adjacent to Port Authority upland property, private upland property, and open water areas. The application may be completed and signed by either the applicant, authorized agent, or preparer. Applicants are encouraged to consult with the Channel Infrastructure Real Property Department concerning the types and levels of detail required. Applicants whose projects require a Federal, City, or County permit are encouraged to apply for that permit concurrent with this application.

Fees: \$1,000 Application Fee
\$10,000 As-Built Deposit
Lease fees to be calculated by the Port Authority (See *Fee Schedule*)

General Instructions

1. Complete and sign the application, put N/A if not applicable.
 - a. *Company Name*: Legal company name as listed with the Office of the Secretary of State or other licensing entity (*Documentation may be required*)
 - b. *Emergency Contact*: Person or call center available 24/7 in case of emergency
 - c. *Corporate Officer*: A person who has authority to bind the company, and the entity type generally determines who has such authority. The proper person to sign is: (a) the president, vice-president or other senior officer of a corporation, witnessed by the corporate secretary or assistant secretary; (b) the partner of a general partnership, properly witnessed; (c) the owner of a sole proprietorship, properly witnessed; and (c) the general partner of a limited partnership, properly witnessed. If someone other than the person listed is signing, or a witness does not additionally sign, proper papers authorizing that action must be submitted (corporate resolution or attorney-in-fact designation)
 - d. *Proposed Use and Project Description*: Provide the intended use (barge fleeting or barge staging) and describe the overall project, including dredging, bulkheads, pilings, spud barges, access areas, etc.
 - e. *Encumbered Area*: (i) the area between the shoreline and the Fleeting Area; and (ii) if dredged, the area between the Fleeting Area and the Channel.
 - f. *Filled Area*: the area taken up by structures such as pilings and docks, or by filled-in areas that were previously submerged.
 - g. *Fleeting Area*: the area used for Barge Fleeting, Barge Staging, or for parking barges.
2. Drawing(s) for all proposed and existing work to be submitted on 8.5" x 11", 8.5" x 14", or 11" x 17" prints or Adobe Acrobat .pdf format. Drawings to include a vicinity map, plan view, and profile view. See sample drawing.
3. Submit the application package and fee(s) as indicated below. The application package includes the completed and signed application, required documentation, and copy of payment.
